Lodging Nominations

Nominations open on 10/06/2025 and must reach the Returning Officer, Jackie McHenry not later than 12 midday Australian Eastern Standard Time (AEST) on 25/06/2025.

The candidate nominates for the election in writing, specifying the office for which they are nominating for.

Prospective candidates and nominators should verify their financial status and any other qualifications required by the Organisation's rules prior to lodging nominations.

Nominations must be lodged via the following method:

By Email: A properly completed nomination form including all necessary signatures and attachments may be scanned and submitted as a **PDF** file to **IEBnominations@aec.gov.au**

The email subject line should include reference: **ANDBU – E2025/65 UFUA Nomination – [Your Name & Nominated Office]**

PLEASE NOTE:

1. Emails to the AEC inbox that appear to be spam may be blocked. It is the responsibility of senders to ensure that their email reaches the AEC before the deadline for nominations.
2. In order to be able to be received by the AEC, emails (including attachments) should be no greater than 6 MB in size.

Withdrawing Nominations

Nominations cannot be withdrawn after 12 midday AEST on 02/07/2025.

Scrutineer Appointment

The appointment of scrutineers opens on 10/06/2025 and closes 12 midday AEST on 13/07/2025.

A form is available from the Returning Officer for the purposes of appointing Scrutineers.

Voting Period

The ballot, if required, will open on 14/07/2025 and close at 5:00pm AEST on 08/08/2025. A postal vote pack will be mailed to eligible voters on 14/07/2025.

If you are on the roll of voters, a replacement ballot pack will be sent by regular mail.
